Chronology:

until 1991: part of the National Committee ICOMOS Yugoslavia, the last president of ICOMOS/YU was the Slovenian archaeologist Dr. Iva Mikl Curk

1993: independent national committee ICOMOS Slovenia included in **ICOMOS** International

1994: the president of the Slovenian section becomes Jovo Grobovšek, who also becomes member of Advisory Committee of **ICOMOS** International

1999, 10 February: Founding Assembly of the Council on Monuments and Sites by adopting the ICOMOS/SI Statute in Ljubljana

2003: In the Conservation Doctrine Series, ICOMOS/SI publishes translations of ICOMOS international charters - Doctrine 1

2008, July: new presidency is elected at an extraordinary annual members' meeting, the new president is Mag. Marko Stokin

2011, October: ICOMOS/SI organises a meeting of presidents and representatives of national committees of Austria, Bosnia and Herzegovina, Montenegro, Croatia, Italy, Hungary, Macedonia, Serbia, and Slovenia, where The Declaration on Regional Cooperation in **Cultural Heritage Conservation is signed**

2012, May: 1st International Symposium on Cultural Heritage and Legal Issues with the main theme International Legal Standards for the Heritage Protection in a Period of Economic Recession and Tools for Safeguarding Protection Standards at Bled.

2014: In the Conservation Doctrine Series, ICOMOS/SI publishes translations of ICOMOS international charters and documents -**Doctrine 2**

September 2015: ICOMOS Slovenia signs a Memorandum of Cooperation with the Council of Europe, Managing Diversity Division, Directorate for the Democratic Governance, to promote Council of Europe's conventions and principles related to industrial heritage

October 2015: 2nd International Symposium on Cultural Heritage and Legal Issues with the main theme Protection and Reuse of Industrial Heritage: Dilemmas, problems, examples. The event was prepared in cooperation with the Institute for Protection of the Cultural Heritage of Slovenia and supported by the Council of Europe, Managing Diversity Division, Directorate for the Democratic Governance

2016: ICOMOS Slovenia publishes, with the financial support of the Slovenian National Commission for UNESCO and the Institute for Protection of the Cultural Heritage of Slovenia, a booklet entitled **Heritage of Slovenia and UNESCO**

2017, November: new presidency is elected, the president of ICOMOS Slovenia becomes Dr. Sonja Ifko

2017: Based on its active work, ICOMOS Slovenia acquires the status of a society in the public interest in culture, allowing co-financing opportunities by the Ministry of Culture

2018, September: 3rd International Symposium on Cultural Heritage and Legal Issues. The topic was Management of the Cultural **Heritage Sites.**



Care for professional high-quality work in cultural heritage conservation in Slovenia

goals:

preservation of heritage in line with internationally established ICOMOS principles, recommendations, conventions, and charters on cultural heritage conservation as the basis of democratic and sustainable

development

actions:

- Translation of ICOMOS charters as part of the Conservation Doctrine Series – Doctrine 3 is being prepared
- Organisation of events where professional and broader communities are acquainted with the principles of conservation. Here we collaborate with the Association of Municipalities and Towns of Slovenia and other stakeholders.
- Organisation of international symposia in Bled, to connect professionals from Slovenia and abroad, with a focus on the professionals form the region – You are kindly invited to the 4th Symposium to take place in autumn 2021 in Bled!
- We will make arrangements with the Ministry of Culture to translate the European Quality Principles for EU-funded Interventions with Potential Impact upon Cultural Heritage

Rejuvenation of the NC by involving emerging professionals and students

goals:

To foster interest among young people to join the NC. In particular, to promote intensive links with universities both in Slovenia and abroad, particularly those in the region, to jointly develop external cooperation related to heritage protection as well as promote education on the field of cultural heritage.

actions:

- Lectures are organised together with the University of Ljubljana, Faculty of Architecture, and students are invited to take part.
- Together with the University of Ljubljana we wish to join the **ICOMOS University Forum**
- We are putting forward the initiative for regional integration of universities!
- We are changing the statute to introduce the category of national membership for emerging professionals and students, which will simplify their involvement in the NC.

goals:

actions:

- We published a booklet entitled Slovenia and World Heritage
- On 3 December 2019 we will hold a working meeting ICOMOS Slovenia and World heritage in Slovenia to open the dialgo with intersted involved and responsible administrative bodies in Slovenia
